On Friday evening, we are delighted to have Todd Main, Deputy Director of the Illinois Department of Natural Resources, as our keynote speaker. He will inform us about Invasive Species, including the latest on the Asian Carp, as well as the Millennium Reserve System.

On Saturday morning, we will begin our day with an informal discussion of how to be an effective advocate. After breakfast, Debra Shore, Commissioner of the Metropolitan Water Reclamation District of Greater Chicago, will address the increasingly frequent problem of stormwater and wastewater discharges known as combined sewer overflows. After our LMLWV business meeting, we are very pleased to have Judy Beck, Lake Michigan Manager for the US EPA, report on the State of Lake Michigan.

We have planned two tours to educate us about the Calumet region. On Friday afternoon, we will tour the Lake Calumet area by trolley, learning about the interplay of remaining wilderness areas with industry and landfills. On Saturday, we are offering a free walk through Beaubien Woods, led by Jean Sellar, a steward from Friends of the Forest Preserves. LMLWV members have advocated for federal Great Lakes Restoration Initiative (GLRI) funding, which is the source of funds for projects to restore wetlands and remove invasive species in Beaubien Woods.

Each local League that has paid membership in LMLWV League is entitled to one vote in the proceedings at the Annual Meeting.
